The special meeting of the Board of Trustees of the University of Arkansas was called to order at 3:39 p.m. on Thursday, July 18, 2024, in Little Rock, Arkansas, and via virtually. Upon motion of Trustee Dickey and second by Trustee Wilson, Chair Eichler stated the Board would go into Executive Session for the purpose of considering the employment, appointment or resignation of public officers or employees for the various campuses of the University of Arkansas System.

#### 1. Executive Session:

Chair Eichler reconvened the Regular Session of the Board at 4:37 p.m. and called for action on the following matter discussed in Executive Session:

## Approval Concerning Dr. Donald R. Bobbitt's Retirement as President:

Upon motion by Trustee Dickey and second by Trustee Fryar, the Board accepted President Donald R. Bobbitt's retirement request and authorized Chair Eichler to negotiate with Dr. Bobbitt more specific terms of a retirement agreement enabling the Board to plan for transition upon the selection of a new president.

# 2. Regular Session:

Chair Eichler made comments publicly thanking President Bobbitt for his 13 years of service as a "consummate professional," and that the president is "leaving the System in a strong position," for which the Board is "incredibly grateful." Trustee Fryar stated that Dr. Bobbitt had done a "great job." Trustee Ford said that he, "would love to compliment (Dr. Bobbitt) for the work that he's done, the team that he's built and the progress they've made," and that he has "tremendous respect and gratitude" for the leader — and the man — that (Dr. Bobbitt) is, adding that he (Ford) values him greatly and is "immensely grateful" for his work.

Chair Eichler further stated that she has given thought to the future leadership and wanted to appoint Trustee Ford to head up the search, calling on a vote as follows.

# Approval Concerning Commencing a Search for a New President of the UA System

Upon motion by Trustee Dickey and second by Trustee Wilson, the Board voted to appoint Trustee Scott Ford to lead the effort to fill the position of President and to work with the UA Foundation to seek the services of, and contract with, a search firm to be paid from private funds.

There being no further business to come before the Board, upon motion by Trustee Dickey and second by Trustee Wilson, the meeting adjourned at 4:42 p.m.
